#### SOFT COMMITTEE NEWS H. Horton McCurdy, PhD, SOFT Vice President

Dr. Rosemary Kincaid, President of SOFT Inc., has chosen this year several topics for committee reports that should prove to be both exciting and informative to all SOFT members. Of special interest should be the Environmental Toxicology Committees. These SOFT committees include the Natural Poisons Committee headed by Vina Spiehler. This committee hopes to organize annotated bibliographies of the pertinent literature involving plant poisons. Dr. Theodore Siek will chair the Pesticides Committee. This committee's goals will be to collect human analytical data similar to the Human Toxicology Registry. The Noxious Chemical Exposure Committee, chaired by Dr. Frederic Rieders, will seek to collect analytical data on noxious substances found indoors which can be detected by routine postmortem toxicological analysis. These special committees will report on their results and findings at the Reno meeting. These reports should prove to be most rewarding.

Dr. Everett Solomons will serve as the committee chairman for the Driving-Under-the-Influence of Drugs (DUID) Committee. The announced projects will involve analytical methods and quality assurance. The interpretation of results, i.e. the adverse effects of drugs on driving ability, continues to be a hotly debated issue among some toxicologists and is also a matter of continuing investigation by this committee in great detail. The results of one study by this committee involving the effects of certain drugs on driving ability should be forthcoming.

Dr. Richard Phillips reports from the Grants and Endowments Committee that the \$10 yearly dues assessment will begin this year. This tax deductible "gift" to the Education Research Award (ERA) will help to build a sufficiently large financial base through which the ERA can hopefully be supported on an ongoing basis. Also this year, Dr. Yale Caplan's ERA Committee with approval by the board of directors awarded five ERA awards to students studying forensic toxicology in the amounts of \$500 each.

Dr. Nancy Chen is busy collecting toxicology reports from various agencies around the country for her committee on Toxicology Reporting. The results of this survey will be reported on at the Fall meeting in Reno.

The Evaluated Methods Committee is headed once again by Dr. Robert Bost. This committee has selected a method for evaluation and if fruitions come to bear, an evaluated method for ethylene glycol and evaluation guidelines should be forthcoming.

Several new members have been added to the membership roster according to Dr. Nick Hodnett, chairman of the Membership Committee and so far none have been dropped. The total membership in SOFT now stands at some 230 strong.

Other SOFT committees are reporting significant progress also. The JAT Special Issue co-chaired by Dr. Marina Stajic and Dr. Yale Caplan is coming along nicely with the submission of a number of papers for consideration for publication. Dr. Mike Schaffer is chairing the Right-to-Know Committee whose function is to provide information concerning various State's right-to-know laws. Mr. Mark Lewis's Meeting Site Committee reports commitments through 1988 with 1989 and 1990 still open. The Budget and Finance Committee and the Audit Committee are considering the possibilities of having a CPA conduct an audit of SOFT financial records.

This brings us up-to-date concerning the current activities of the committees of SOFT. Most members have served on SOFT committees because they have expressed an interest in doing so. Therefore, if you, as a member of SOFT, have an interest in serving on a committee of SOFT, we would enjoy hearing from you.

## IN MEMORIAM — DR. MILTON BASTOS

An unexpected phone call at about six one evening was my introduction to Milton Bastos. As I was preparing to go to the International Association of Forensic Scientists' banquet in Toronto in June, 1973. This call came as a real surprise. It marked the culmination of Milton's escape from Brazil via a circuitous route - after stealing across the Uraguayan border and into Argentina, he got to Buenos Aires, flew up the coast of South America avoiding Rio en route. to finally reach Toronto almost penniless. Because of a change in regime, his Guggenheim Fellowship and his sabbatical leave had been suddenly withdrawn just before he was to depart for a period of study at the Cuvahoga County Coroner's Office in Cleveland, Ohio. He came, nonetheless, determined to seek the educational opportunities he felt were essential to his professional growth. He proved to be an apt and

diligent co-worker, absorbing new material like a wet sponge. Fortunately, a small research grant was obtained to ensure his sustenance as he continued to contribute. His excellent article on identification of Organic Bases by TLC brought requests for over 1,000 reprints! Recognition of his potential brought Dr. Bastos an invitation to join the New York State Drug Analysis Program. While working with Dr. Salvatore Mulé and other associates, he developed a host of innovative techniques for the effective analysis of large numbers of specimens. He shared these methods through his many publications. The next challenge Milton met was as Director of Toxicology in the New York City Chief Medical Examiner's Office. There he tried to reorganize and modernize the Toxicology Laboratory, with moderate success. Discouraged and homesick after

years of service in New York, he decided to return to Rio de Janeiro. There he was reinstated, and he resumed his professional duties. Unfortunately, he was not destined to enjoy this privilege for long. A sudden fulminating heart attack carried him away on 28 July 1985.

Everyone who knew Milton suffered from his demise. He was a true gentleman in the literal sense of that word. His courtly manner and his love for all his fellow beings was readily apparent at every encounter. Whenever he made his feelings known, they were always kindly disposed. In addition to all these attributes, Milton was a loving husband, a supportive father and a devoted friend. We were fortunate to have him with us, and he is gone only from this world. His work and his friendship will be with us and others for many a year.
