#### PRESIDENT: ROBERT O. BOST, PH.D.

Dr. Bost received his M.S. and Ph.D. degrees in Organic Chemistry from the University of Houston in 1970. He has been an ABFT Diplomate since 1980. Since 1987, Dr. Bost has served as Chief Toxicologist for the Southwest Institute of Forensic Sciences amd as Assistant Professor in the Pathology Dept. at the University of Texas Southwestern Medical Center. He has served on the SOFT Board of Directors (1986-88), several SOFT committees, and is the current SOFT Vice President. Dr. Bost is also a member of AAFS, TIAFT, and ACS.

#### VICE PRESIDENT: WILLIAM H. ANDERSON, PH.D.

Dr. Anderson received his Ph.D. from the University of Tennessee Center for the Health Sciences. After working in the Tennessee Medical Examiner System and academic positions, he served as Deputy Chief Toxicologist at the Oklahoma Medical Examiner's Office until 1987. Dr. Anderson is currently the Chief Toxicologist for Sierra Nevada Laboratories in Reno. He has held a variety of positions in SOFT, including a current member of the Board, Chairman of the Budget, Audit & Finance Committee, Membership Committee, and co-presentor of the 1983 SOFT Capillary Chromatography Workshop. His professional experiences include several publications and presentations and membership in AAFS, SAFS, past-president of SAT, and member of the Crime Lab Digest editorial board.

Dr. Poklis graduated from the University of Maryland in 1974 with a Ph.D. Toxicology. From Midway Airport - Continental's AIRPORT EXPRESS departs every 15 minutes 8 am to 8:30 pm (shorter weekend hours) for \$8 one way, \$14 round trip (\$1 coupon in ToxTalk); counter in Midway Airlines baggage claim area. CAB FARE: about \$16.00 and the drive is shorter than from O'Hare.
