S.O.F.T. Annual Meeting: A Summary

The Society of Forensic Toxicology held its 22nd Annual Meeting in Cromwell Connecticut on October 13-16th, 1992. The week started off on Tuesday with an excellent full day workshop on "Alcohol Testing in the Transportation Workplace". The primary focus of the workshop was on the Omnibus Transportation Employee Testing Act of 1991. Donna Smith, with the Office of the Secretary, Dept. of Transportation, presented an overview of the DOT proposal for preemployment, random, and post accident testing. This was an excellent forum to examine the issues and provide input from the viewpoint of the forensic toxicologist.

A second full day workshop was conducted Wednesday on "The PC in the Toxicology Laboratory". Various options available in PC hardware and Software were explored in relation to the toxicology laboratory's needs. Two additional half day workshops were conducted on Wednesday. "NIDA Certification Inspections" covered many common problem areas encountered in the NIDA laboratories by inspectors. As presented in the workshop, one of the more difficult areas of the inspection is the GC-MS data review. The workshop, "Training and Professional Development in Toxicology", looked at the need for ongoing training for forensic toxicologists. An overview of the training efforts of the California Association of Toxicologists and the Canadian RCMP Laboratories was presented. In addition, a training module on "The Medical Examiners Laboratory" was presented. On Wednesday evening, the Elmer Gordon Open Forum was extremely well attended, with a wide variety of discussion topics including analysis of specimens from cocaine babies.

There were 26 platforms and 11 posters presented on Thursday and Friday. Cocaine ingestion, toxicity, and detection of surface residues from smoking Crack was the subject of a number of presentations. Instrumental techniques on Kinetic EIA, EMIT II, GC-IR, GC-NPD, and GC-MS for drug analyses were also covered. Case reports were presented on Triamterene, Methomyl, Metoprolol Verapamil, Fentanyl, and Paraquat. The report of the SOFT Advisory Committee on the "Consensus on Applicability of Hair Analysis for Drugs of Abuse" was presented as a platform on Thursday afternoon followed by an open discussion. A large group stayed into early evening providing input for the policy statement. The Committee worked late into the evening revising the policy statement for presentation at the SOFT Business meeting where it was accepted by a majority vote. A large round of THANKS to the dedicated Committee members, W. Lee Hearn, Ph.D., Bruce Goldberger, Ph.D., Marilyn Huestis, Ph.D., Brian Donnelly, Ph.D., and Jane Speaker, Ph.D., for their work prior to and during the annual meeting to finalize this project.

At the SOFT Awards luncheon, President Jeanne Beno, Ph.D., recognized Neil Reading, Ph.D., Joel Milzoff, Ph.D., and the program committee for their work in organizing an outstanding 1992 meeting. The officers and board members of SOFT were acknowledged, with a special recognition to Mark B. Lewis for his outstanding work as SOFT Treasurer for two terms. Mark will be serving as Vice President of SOFT this next year. Alphonse Polkis, Ph.D., was recognized for his work this past year as Vice President. Al will be serving as the incoming President of SOFT. Two SOFT ERA recipients were recognized: Philip M. Kemp for his work on "Differentiating Usage patterns of Marihuana Utilizing Gas Chromatography/Mass Spectrometry" and Bruce Walker for his work on "Matrix Effects in Forensic Samples Affecting the Analysis of Psychotropic Agents". Preston Publications presented an award to H. Chip Walls for his work as special editor of the SOFT issue of the Journal of Analytical Toxicology.

REVISED CONSENSUS OPINION ON APPLICABILITY OF HAIR ANALYSIS FOR DRUGS OF ABUSE

Prepared by the SOFT Advisory Committee October 15, 1992

The issue of testing of drugs of abuse in hair can be divided into three different components: analytical considerations, interpretation of hair test results, and applicability of the technique to various settings. This report deals primarily with the application of testing of drugs of abuse in hair to the workplace testing arena. The use of hair analysis for employee and pre-employment drug testing cannot be supported by the current information on hair analysis for drugs of abuse. However, hair analysis may be useful in other forensic investigations when the data are supported by other competent evidence of drug use.

Before a laboratory reports results of hair analysis for drugs in any context, its methods must be fully validated. Assay characterization, including assessment of accuracy, precision, sensitivity and specificity, must be documented. All details of procedures used for the analysis of specimens and all data that serve as the basis of a positive finding as well as related quality control data must be available for peer review.

The reporting of a positive result based upon a single or replicate immunoassay is not acceptable in situations where <u>any</u> adverse action is reasonably anticipated. Adverse consequences should not be imposed upon an individual based solely upon uncomfirmed immunoassay results obtained from the analysis of hair as well as any other biological specimen. In clinical situations, a presumptive positive may be reported only if the report indicates that the result was not confirmed. All positive presumptive tests having any forensic implications must be confirmed by a second independent test prior to reporting a final result. Currently, GC/MS, GC/MS/MS, and MS/MS are the only technologies offering sufficient sensitivity and specificity for use in confirming presumptive positive hair analysis results.

Critical questions remain to be answered before the results of hair drug tests for workplace applications can be accurately interpreted. Among these are:

- a. Is incorporation, retention, and analytical detection of drugs in hair biased by race, age, sex, or other individual differences?
- b. To what extent is an externally applied drug from environmental exposure retained in hair, and what effect(s) do hygienic washing practices and cosmetic treatments have on externally applied drugs?
- c. Is retention and detection of drugs in hair affected by cosmetic treatments or by intentional efforts to avoid detection?
- d. Do various laboratory hair pretreatment procedures effectively remove externally applied drug or internally incorporated/bound drug? Are washing procedures effective in distinguishing between environmental contamination and internal incorporation of drugs?
- e. What acceptance criteria should be utilized to establish a positive hair drug testing result?

CONCLUSION: Some unanswered questions indicating important deficiencies in our present knowledge of the analysis of hair are delineated above. The committee concluded that, because of these deficiencies, results of hair analysis alone do not constitute sufficient evidence of drug use for application in the workplace.


