PRESIDENT Amanda J. Jenkins, Ph.D., D-ABC, D-FTCB

Amanda Jenkins is currently the Chief Toxicologist for the Office of the Cuyahoga County Coroner in Cleveland, Ohio. She is also an Associate Professor in the Department of Pathology, School of Medicine at Case Western Reserve University. Dr. Jenkins received a Bachelor of Science degree in Biochemistry and Physiology from the University of Leeds, England; a Master of Science degree in Forensic Science from Strathclyde University in Glasgow, Scotland; and a Ph.D. in Toxicology from the University of Maryland. Dr. Jenkins' previous positions include working as an Assistant Toxicologist at the Office of the Chief Medical Examiner, State of Maryland, in Baltimore. She conducted her doctoral thesis at the Intramural Research Program, National Institute on Drug Abuse at the National Institutes of Health.

Amanda has served SOFT as a member of the Health and Safety Committee and Membership Committee. She was the scientific program co-chair for the 1996 SOFT annual meeting in Denver, a member of the Board of Directors from 1997 to 1999, Secretary from 2000-2001 and currently serves as vice-president and member of the Drug Facilitated Sexual Assault Committee. She is the scientific program chair for the SOFT Meeting in Detroit this year. She also serves on the Editorial Board of the Journal of Analytical Toxicology, is a Laboratory Inspector for the College of American Pathologists FUDT accreditation program; a Fellow of the American Academy of Forensic Sciences Toxicology Section and a member of The International Association of Forensic Toxicologists.

VICE PRESIDENT Daniel Isenschmid, Ph.D., DABFT

Daniel S. Isenschmid is currently Chief Toxicologist at the Office of the Wayne County Medical Examiner in Detroit. He is also a Clinical Assistant Professor and Adjunct Assistant Professor, respectively, at Wayne State University's School of Medicine and College of Pharmacy and Allied Health Professions. Dr. Isenschmid received his M.S. and Ph.D. degrees in pathology and forensic toxicology, respectively, from the University of Maryland at Baltimore, School of Medicine. Dr. Isenschmid was the recipient of several Educational Research Awards from SOFT and the Irving Sunshine Award from the American Academy of Forensic Sciences for his doctoral research on cocaine. He has published and/or presented numerous papers on various topics in forensic toxicology.

Dr. Isenschmid is an Inspector for the National Laboratory Certification Program and the College of American Pathologists. He served as a member of the Drug Testing Advisory Board (DTAB) for SAMHSA from 1997 - 2001. He is a member of the Society of Forensic Toxicologists for which he is currently Treasurer, and is a Fellow of the American Academy of Forensic Sciences and is currently serving on its Board of Directors. TREASURER Timothy Rohrig, Ph.D., DABFT

Dr. Rohrig is currently Director, Forensic Science Laboratories and Chief Toxicologist at the Regional Forensic Science Center, Sedgwick County, Kansas. Prior to joining the Center he was Director of Laboratories at the Center for Forensic Sciences, Onondaga County, NY. Dr. Rohrig was previously, Vice President and Director of Toxicology of Osborn Laboratories, Chief Toxicologist and Laboratory Director for the Office of the Chief Medical Examiner, State of Oklahoma. During his tenure in Oklahoma, he was a consultant to the Oklahoma State Bureau of Investigation Crime Laboratory. Other previous positions include Toxicologist for the Office of the Chief Medical Examiner, State of West Virginia and Chief Toxicologist for the Kansas Bureau of Investigation's Forensic Science Laboratory.

Dr. Rohrig holds the academic position of Clinical Assistant Professor of Pathology at the University of Kansas School of Medicine-Wichita. He was previously a Clinical Assistant Professor of Pathology at SUNY Health Science Center at Syracuse, NY and an Adjunct Assistant Professor of Pharmacology and Toxicology at the University of Oklahoma, Health Sciences Center-College of Pharmacy.

Dr. Rohrig holds a Bachelor of Science degree in Chemistry, a Doctorate with an emphasis in Pharmacology/Toxicology, and is board certified by the American Board of Forensic Toxicology. Dr. Rohrig also holds a New York State Laboratory Director License. He serves as a Laboratory Inspector and Team Leader for the U.S. Government's National Laboratory Certification Program. Dr. Rohrig has authored over fifteen peer-reviewed articles and given numerous scientific oral presentations in the field of toxicology.

Dr. Rohrig is a longtime member of SOFT where he currently serves as a Director. Additional affiliations include a Fellow of the American Academy of Forensic Sciences, a member of several other professional organizations, including the International Association of Forensic Toxicologists and the Wichita Area SANE/SART Steering Committee. He was previously a member and Vice Chair of the New York Crime Laboratory Advisory Committee.

Dr. Rohrig's current research interests include postmortem distribution of drugs, interpretive postmortem toxicology and the effects of drugs on human performance.

DIRECTOR Christine Moore, Ph.D., DABCC

Christine Moore, Ph.D. is currently the Laboratory Director of U.S. Drug Testing Laboratories, Des Plaines, IL, a company specializing in the analysis of drugs in various biological tissues including meconium, hair, urine, blood and nails. Dr. Moore has a Bachelor of Science (Honours) degree in Applied Chemistry from the University of Salford, England (1985), a Master of Science degree in Forensic Science from the University of Strathclyde, Scotland (1986), and a Ph.D. in Forensic Toxicology from the University of Glasgow, Scotland (1989). Additionally, she is a Diplomate of the American Board of Clinical Chemistry (DABCC).

Following a post-doctoral year at the University of Nagoya, Japan, Dr. Moore served as a Research Associate at the University of Illinois at Chicago. From 1992 to 1994 she was employed by United Chemical Technologies, PA, a company specializing in the manufacture of solid-phase extraction cartridges, as Technical Services Manager. In March, 1994 she joined U.S. Drug Testing Laboratories where she is still employed. Dr. Moore has published over 50 research articles in peer-reviewed journals. She has presented her research at national and international conferences and has participated in, and coordinated workshops on alternative matrices for drug testing, analytical instrumentation and hair analysis.

Christine is a member of the American Academy of Forensic Sciences, the Society of Forensic Toxicologists, the International Association of Toxicologists, the American Association of Clinical Chemistry, the Research Society on Alcoholism, the Society of Hair Testing, the Southwestern Association of Toxicologists, the American Chemical Society and the Royal Society of Chemistry. DRUGS IN THE NEWS

BOTOX PARTIES - A NEW DRUG TREND?

Botox is a very weak solution of bacterial toxin which, when injected into a muscle, causes paralysis that can last 3-4 months. Traditionally, Botox, consisting of a small dose of the *Botulinum Toxin*, has been used to treat involuntary twitching of the eyes.

Recently, the FDA approved the use of Botox for cosmetic purposes. An interested party is presented with a quick lecture on the risks involved with this procedure. The injections, costing as much as \$500 each, smooth wrinkles by paralyzing underlying facial muscles. The most severe risks include long-lasting migraine headaches. One of the concerns with Botox is creation of the "Botox mask" – a face that is flat and expressionless. \$\mathbb{Z}\$

SALVIA DIVINORUM (SD) [from a website]

Salvia divinorum (SD) is a type of sage plant grown in Mexico which can cause intense hallucinations, out-of-body experiences and, when taken in higher doses, unconsciousness and short-term memory loss. Users have also reported sensations of traveling through time and space, assuming the identities of other people and even merging with inanimate objects. Salvia divinorum usually makes those who take it more introverted. Its active ingredient is Salvinorin A and it is also known as ska Maria Pastora and diviner's sage.

A neurologist stated that "It is really in a class by itself." It does not appear to work on the neurotransmitter systems of the brain. SD can be smoked, chewed or brewed into an intoxicating tea. Its harsh smoke, bitter taste and relatively short-term effects — it lasts about an hour — also keep it from being truly user-friendly.

Its effect does not make it a popular drug for parties, unlike Ecstasy or LSD, as it is a rather unsociable drug. It was reported that only about 1 of every 10 users repeats his SD experience.

TECHNICAL NOTES

Keith Williams, a colleague from the United Kingdom, recently reported at the annual U.S. Department of Defense Tri-Service Meeting that several urine samples have been found to contain 6-acetyl morphine with no other opiate detected. Methodology and cut-offs are identical to those mandated by the NLCP. The concentrations of 6-acetyl morphine ranged from 60 to 600 ng/ml. If anyone has experienced this unusual finding, please share the information with ToxTalk.

CASE NOTES

Toxicological aspects after the enjoyment of Bolivian Herbal Coca Tea

Coca Tea is legally marketed and exported in South America. In contrast, it is illegal to import these products to European countries, such as Switzerland. The Institute for Forensic Medicine were given several hundred bags of Mate Windsor "Mate de Coca", which had been brought into Switzerland from Bolivia by holiday travelers who were unaware of the illegality of this act.

Quantitative Examination of Herbal Tea Bag:

The herbal tea bags and the steeped tea were analyzed by GCMS using a HFIP/PFPA derivative. In addition to cocaine, cis and trans cinnamoylcocaine as well as ecgoninemethylester were detected. Five tea bags were individually extracted twice with 70 ml methanol. The cocaine content in the extracts was determined by GC FID. The tea bags weighed 850 grams. The average total cocaine extracted in the two extracts was 5.7 + 0.9 = 6.6 mg. This represents 0.77% of the tea bag weight. The 6.6 mg of cocaine in the tea bags is clearly higher than levels previously reported in the literature in similar herbal tea products.

The steeped tea was evaporated quickly to dryness in a rotating evaporator, and the cocaine concentration was determined using GC FID. It was determined that the cocaine concentration in the steeped tea decreased over time. After steeping 15 minutes, the tea contained approximately 2.9 mg of cocaine; while 4 –5 hours after tea preparation, 1.8 mg of cocaine were found; and, finally, after 3 weeks the cocaine concentration dropped to 0.7 mg. Additionally, 5.3 mg of BE were also detected. No BE determinations were made for the 15 min and 4-5 hour teas.

Urinalysis:

Two subjects drank 1 cup of tea prepared with 1 tea bag 10 minutes after preparation. They, therefore, ingested approximately 3 mg of cocaine. The urine of these subjects was collected over 2 days and tested by the Online, Cedia and FPIA immunoassays. Assays were performed as directed by the manufacturer.

Between 26 to 32 hours post injection, all three assays showed that the tea caused positive BE levels in urine exceeding the 300 ng/ml cutoff level. If the concentration of BE is divided by the concentration of creatinine, that ratio never exceeded a level of 300 for any sample tested. The first urine samples collected from the subjects 1 hour after drinking the tea found traces of cocaine by solid phase extraction and LCMS.

Blood collected from the subjects 1 and 8 hours after drinking was tested for cocaine and BE by GCMS. The values are shown below.

Annual Business Meeting Minutes of the Society of Forensic Toxicologists, Inc.

October 3, 2001

The Annual Business meeting of the Society of Forensic Toxicologists, Inc., (SOFT) was held on October 3, 2001 in New Orleans, LA. President Michael Smith, Ph.D. called the meeting to order at 3.35 p.m. and requested that the Secretary establish a quorum. Upon a motion duly made, seconded and passed, the agenda was approved with no corrections. By a motion duly made, seconded and passed, the minutes of the annual business meeting of the Society of Forensic Toxicologists, Inc., of October 4, 2000, as published in ToxTalk, were approved by acclamation.

President's Report: Michael L. Smith, Ph.D.: President Smith thanked the members of SOFT for their support in the aftermath of the September 11 terrorist attacks. He made the observation that many were indisbelief about what had happened and suggested that we should all continue with life as individuals, toxicologists and as a society. He questioned what our role as toxicologists should be in any response, noting that much of the world's heroin is produced in Afghanistan. In conclusion, Dr Smith thanked the Board or their hard work and Tinsley Preston, Dr Rohrig and colleagues for the SOFT JAT Special Issue.

Secretary's Report: Amanda J. Jenkins, Ph.D.: Secretary Jenkins thanked the Society for the opportunity and privilege of serving as Secretary.

Treasurer's Report: Daniel Isenschmid, Ph.D.: Treasurer Isenschmid reported that SOFT is in good financial condition with assets totaling over \$222,000. These assets included \$25,000 in permanent reserve and an ERA Fund Balance of \$90,181.90. The Treasurer noted that there were 2 ERA awards in 2001. In addition to the awards, the publishing costs for the SOFT Special Issue of JAT were met from the ERA fund. Therefore, the Society had \$107,098.11 in available funds.

Vice President's and Committee Reports: Laurel Farrell, B.A.: Vice President Farrell called on the committee chairs to give their reports:

- A. <u>Bylaws</u>, Yale Caplan, Ph.D.: A draft amendment to the Bylaws was published in ToxTalk regarding the Ethics committee. Dr Caplan made a motion that the bylaws be approved by the Society as published. The amendment was approved by acclamation.
- B. <u>Budget</u>, <u>Finance</u>, <u>& Audit</u>, Ruth Winecker, Ph.D.: Dr Winecker reported that the Treasurer's report from Jan 1,- August 31, 2001 was reviewed by the

committee and found to be clear, concise and in good order.

C. Membership, Amanda Jenkins, Ph.D.: Dr Jenkins informed the membership that the current committee members were Daniel Anderson, Glynn Chaney, Dr Michael Baylor and herself as Chair. Membership in SOFT totaled 610 with 455 full members, 94 Associate, 19 Charter, 17 Retired Charter, 13 Retired, and 12 student members. Secretary Jenkins stated that between Jan 1-Oct 1 there was action on 37 applications. New members were recognized by the meeting attendees. Dr Jenkins also stated that in the past year 21 members were removed from membership due to non-payment of dues. She reinforced to members the need to notify the office in Arizona about address changes as Ms. Fulmer maintains the database.

Dr Jenkins stated that the reinstatement application form has been amended. The Board approved amendments which require the applicant to initial beside the questions and provide justification for reinstatement.

A request from Dr Pinder that Charter members be recognized with a permanent listing in the membership directory was approved by the Board. A list of Charter members will be compiled and verified before being added to the directory. The Charter members present were recognized by the attendees.

- D. <u>Nominating</u>, J. Robert Zettl, M.P.A.: Mr Zettl stated that the committee had selected the following individuals for SOFT office for 2002: President-Laurel Farrell, B.A.; Vice President-Amanda Jenkins, Ph.D., Secretary- Graham Jones, Ph.D., Board of Directors-Rod McCutcheon, B.S., Anthony Costantino, Ph.D. and Michael Baylor, Ph.D.
- E. <u>ToxTalk</u>, Joe Monforte, Ph.D.: Dr Monforte thanked the editorial Board. New contributors would be listed in the next issue. Dr Goldberger developed a mechanism for publishing ToxTalk on the web-site. He reminded members to provide the SOFT Administrative Office with changes of address not the publishers of ToxTalk.
- F. <u>Publication (JAT)</u>, Tim Rohrig, Ph.D.: Dr Rohrig stated that he and his colleagues had received more than 30 articles for publication. He thanked the reviewers, contributors, and Mr Tinsley Preston of Preston Publications. Mr Preston presented plaques to Drs Rohrig, Moore, Negrusz and Presley (in absentia) in recognition of their work.

- G. Education Research Award, Barbara Manno, Ph.D.: Dr Manno reported that the committee had received 4 applications. Awards were bestowed on two individuals, Robert Kronstrand and Edward Carter. The award consisted of meeting registration fee waiver and \$1000, to be used to offset travel expenses to attend the meeting. Due to the events of Sept. 11, 2001, Robert Kronstrand was unable to attend the current meeting and therefore, would give his presentation at the 2002 meeting. The certificates were presented by President Smith. Dr Huestis accepted the award for Edward Carter and Dr Jones agreed to transport the award for Robert Kronstrand.
- H. Meeting Resource Committee, Laurel Farrell: Ms. Farrell noted that the committee was to explore the possibility of long term contracts with vendors. She thanked Lisa O'Dell for her hard work with the vendors.

2001 Host Pat Pizzo stated the meeting had 550 registrants with 907 workshop participants and 54 exhibitor booths. President Smith presented a plaque and a gift to Ms. Pizzo in recognition of her work as host of the annual meeting.

2002 Co-Host Brad Hepler, Ph.D. stated the meeting will be held October 13-17, 2002, Sunday-Thursday in Dearborn, Ml. There will be a reception at the Henry Ford museum. Dr Jenkins, the Scientific Program Chair, stated abstracts should be sent to her by mail or email. The deadline is June 1. Details about audiovisual capabilities will be provided on the abstract form. She requested a one page proposal by October 31, 2001 from any individual interested in conducting a workshop. Dr Jenkins stated that anyone interested in helping with the program as abstract reviewers, session moderators, should contact her.

- I. <u>Laboratory Guidelines</u>, Graham Jones, Ph.D.: Dr Jones reported that several changes had been made to the guidelines. The new document will be posted. SOFT and the Toxicology Section of AAFS must approve the changes by vote.
- J. <u>Drugs and Driving Committee</u>, Laurel Farrell, BA: Ms Farrell reported that there were currently more than 40 members on the committee. She stated that the committee directed the publishing of the drug monographs in *Forensic Science Review*. The monographs have formed the basis of a 2 day course to be held in March 2002 on the effects of drugs on driving. Dr Barry Logan is the course co-ordinator. The committee also focussed on workshops and co-chaired the Alcohol workshop at the current meeting and was hosting a one-half day workshop at the AAFS meeting in 2002 and a one day workshop at SOFT 2002.

- K. Policies and Procedures, Dwain Fuller, B.S.: The committee comprised William Anderson, Ph.D., Marilyn Huestis, Ph.D., and Dwain Fuller, B.S. A searchable database has been compiled and will be emailed to the Board for review
- L. Web-site, Bruce Goldberger, Ph.D.: Dr Goldberger stated that there have been 12,196 hits to the home page from April 1-June 30, 2001 with more than 320,000 hits to the entire site. There were approximately 25,000 user sessions averaging more than 4 min. The most requested pages were the employment exchange, laboratory guidelines and Toxilinks. Dr Goldberger stated the Board approved publication of the drug monographs and ToxTalk on the web-site. The site also now has Broadcast capability. Dr Goldberger intended to add a place on the site for members to update their demographic information. He would then forward the information to the Administrative office.
- M. Continuing Education Committee, Jennifer Limoges, M.S.: The intent of this committee was to provide a high quality education opportunity for members at the local level. To date the committee has organized 3 seminars on the chemistry of derivatization with more than 175 attendees. The committee is currently planning a seminar on antidepressants.
- N. <u>Drug Facilitated Sexual Assault Committee,</u> Marc LeBeau, MS.: Marc LeBeau stated that the objective of the committee was to educate fellow scientists, investigators, medical personnel and law enforcement. The committee organized a workshop at the AAFS meeting in 2001 and would be conducting a workshop on GHB at the AAFS meeting in 2002.
- O. Ethics Committee, President Smith: President Smith stated the Board determined that SOFT needed an ethics statement on the membership application form. The committee would be looking into this in the coming year.

Liaison Reports: President Smith

ABFT, Yale Caplan, Ph.D.: Dr Caplan reminded members that SOFT is a sponsoring organization of the ABFT. ABFT has several programs including certification of forensic toxicologists at all degree levels. The organization produces a newsletter and brochures describing these programs. The ABFT has a laboratory accreditation program and he encouraged laboratories conducting postmortem and human performance testing to seek accreditation. The ABFT has representation on FSAB and would be seeking certification from this body. Dr Caplan stated that the ABFT Board had modified its nominating process beginning in 2002. Instead of nominations to serve on the Board from individual organizations, a nominating committee will be formed to perform this task.

AAFS, Brad Hepler, Ph.D.: Dr Hepler stated that the Steering Committee would meet at 5.00 p.m. today.

President Smith: President Smith asked for any unfinished business. There was no unfinished business from the members.

Nominations and Elections: No nominations for SOFT officers were received from the floor. A motion was made and seconded that nominations be closed. All officers were elected by acclamation as presented by the Nomination Committee. The newly elected 2002 SOFT officers and directors are as follows:

President-Laurel Farrell, B.A. Vice President- Amanda Jenkins, Ph.D. Secretary- Graham Jones, Ph.D. Director- Michael Baylor, Ph.D.; Anthony Costantino, Ph.D.; Rod McCutcheon, B.S.

Laurel Farrell presented outgoing President Smith with a commemorative plague on behalf of the members in recognition of his service to SOFT.

Incoming President's Remarks:

Workshop #1 - Sunday, October 13, 2002

8:00 a.m. - 6:00 p.m.

DUID - From Research to the Courts Co-Chairs: Laurel Farrell, B.A., J. Robert Zettl, B.S., M.P.A

This full day workshop will focus on two aspects of DUID cases. Opening remarks, provided by NHTSA, will outline their involvement in DUID programs and research.

The first area of focus will be driving research studies. We will look at both driving simulator and on-the-road research studies. Two researchers will present the components of driving, how their protocols measure performance and if these performance measures are adequate to determine drug impairment. Both will present an overview and summary of results for all studies completed at their facilities and then they will each take one study and go through it in detail. Lastly, they will provide information on future projects.

The second area of focus will be successful prosecution of a DUID case. A prosecutor will review the current DUID statutes, United States and other countries, and pertinent case law in the area of DUID. "What do prosecutors really need to know to successfully prosecute a DUID?" This will be delineated with information provided on formal training available to prosecutors, how toxicologists can get more involved in this training in their states, and how to best provide the informal training many of us do for prosecutors in each case we are involved in. We will also have a representative from the National Judicial College to provide information on the training available to judges.

Pharmacogenomics as an Adjunct for Certifying Drug Toxicity in Forensic Toxicology Chair: Steven Wong, Ph.D.

Pharmacogenomics is an emerging clinical discipline that attempts to correlate drug dose and response to the genomics of the drug metabolizing enzyme and receptors of individual patients. In forensic toxicology genotyping drug metabolizing enzymes may serve as a useful adjunct for assessing drug toxicity. This introductory workshop will establish the basis of molecular biology, and introduce the principles of pharmacogenetics. This information will serve as the basis for assessing the usefulness of pharmacogenomics in deaths involving drugs utilized in psychiatry, addiction, and pain management.

Forensic Toxicological Aspects of Human Growth and Development Chair: Michael Corbett, Ph.D.

This workshop will discuss the impact of age with respect to forensic toxicology. Infants, young children and the elderly vary in pharmacokinetic parameters compared with most adults. Differences in external environments of these individuals such as access to drugs also impact the likelihood of drug detection. Pharmacological and external factors affecting drug detection during growth and development will be delineated.

Solid Phase Extraction: Scientific Theory and Applications in Forensic Toxicology Chair: Michael Telepchak, B.S., M.B.A.

This workshop will discuss the history and development of SPE with emphasis on basic silane chemistry and the manufacturing of bonded silicas. The effects of pH, polarity, and solubility on extraction performance will be delineated. Researchers from Wayne State University in Detroit will present this workshop. Key analytical issues to be addressed are ease of use, sensitivity, linear dynamic range, and quantitation (including the use of co-eluting internal standards). Applications to be discussed using the techniques of MS/MS include drugs in urine, blood, hair and alternate matrices.

CALL FOR PAPERS AND ABSTRACT SUBMISSION

General Information

The Program Committee solicits abstracts on all forensic toxicology topics including postmortem toxicology, forensic urine drug testing, analytical toxicology of drugs, pharmacology as related to forensic toxicology, pathology as related to forensic toxicology, pediatric and geriatric case reports, and the relationship between drug concentrations and performance impairment. Scientific papers selected for presentation will be divided into two groups: 15-minute platform presentations and poster presentations. The Program Committee will select appropriate abstracts from those submitted by the June 1, 2002, deadline. The presenting authors of all papers will be required to register for the meeting. Only abstracts written in English will be considered. The format for the preparation of the abstracts is provided on the submission form.

Platform (Oral) Presentations

NLY 35-mm slides or LCD (PowerPoint) presentations will be accepted. Each presenter will be provided with 10 minutes to present their material and 5 minutes to answer questions. Platform presentations must cover the material reported in the abstract. Regardless whether 35 mm slides or LCD projection are used, information on the slides must be kept simple with plenty of open spaces between lines. Limit information on each slide to seven lines or less. Do not crowd the slide. Avoid backing up in slide lectures. If you need a slide twice, make duplicate slides. White on black, white on blue, blue on yellow or yellow on blue project best. Avoid red and blue or other non-contrasting color combinations. If using 35mm slides, it is highly recommended that you provide your own carousel.

LCD Projector - Policies and Procedures

A LCD projector will be available for use at this meeting. Any LCD format platform presentation MUST be submitted in advance (Deadline September 13, 2002) on 3.5-inch disk or by E-mail in Microsoft PowerPoint (IBM format only) to the Program Chair (contact information on abstract submission form). There will be NO exception to these requirements. All presentations will be pre-loaded and tested on a computer (and backup computer) provided

SOFT. You may bring your own laptop as an additional backup, however in order to improve flow between presentations this will only be used in the event of unexpected technical problems. Slide projectors will be available for presenters who do not meet this deadline, or format requirement.

Poster Presentations

Each author selected for poster presentation will be provided with a 4' x 8' tack board on which to display material related to his or her presentation. Presenters must bring their own tacks. Authors have complete freedom to choose ways of displaying their information in figures, tables, text, photographs, etc; however, they should avoid crowding too much information into a limited space. The poster should be readable from a distance of 3 feet. Posters will be kept up for the entire day they are scheduled. Please be sure your poster is mounted by 8 a.m. and leave it mounted until 5 p.m. It will only be necessary for the author to be present at the poster for the one-hour noted in the program.

Abstract Submission - Abstracts may be submitted in one of two ways:

- Electronically by e-mail Be sure to provide all the information required on the back of this form in the body of your e-mail text. Be sure to type ONE of the disclosure statements in your-email. By submission of your abstract electronically, no signature is required for the disclosure. The abstract itself is to be provided as an attachment in Microsoft Word ONLY using the format described on the back of this form.
- By mail Complete the back of this form. The abstract itself MUST be provided on diskette in Microsoft Word ONLY. Please label the diskette with the presenting author's name. Include four (4) hard copies of the abstract.
