The Meth Labs Saga: Local Prosecutors Cite Meth Clan-Lab Operators with Violation of North Carolina's Weapons of Mass Destruction Statute.

In my home county (Watauga, NC), there were 34 arrests last year for methamphetamine (meth) synthesis. In 2002 there were two. Statewide, we went from about 34 meth clan-lab seizures in 2001 to 96 in 2002, to 177 in 2003, giving our rural county a disproportionate ~20% share of the total. The state expects meth clan-lab seizures to double this year. So, we have a problem.

One of the problems with prosecution of methamphetamine synthesis is that the current state statute is a Class-H felony, the same as for growing a single marijuana plant. Those arrested quickly make bail and are released. There has been a significant recidivism rate - a number of these local defendants now have multiple arrests – once released on bond they go right back to meth production.

In an effort to combat this, our local District Attorney charged 15 of these defendants with an additional charge – violation on North Carolina's Weapons of Mass Destruction law, a Class-B1 Felony. That law, passed quickly in the aftermath of 9/11, makes it a crime for "any person to knowingly manufacture, assemble, possess ...or acquire a nuclear, biological, or chemical weapon of mass destruction (WMD). In the statute, a chemical WMD is defined as "any weapon, device, or method that in designed OR has the capability to cause death or serious injury through the release, dissemination, C IMPACT oftoxic or poisonous chemicals or their immediate precursors," OR "any substance that is designed OR has the capability to produce death or serious injury and is or contains toxic poisonous chemicals or their immediate precursors" (emphasis added).

Obviously, charging under this statute would allow law enforcement to hold defendants in pre-trial custody, reducing their capability to continue their illegal activities. The penalties under this statute are much more severe, as well. However, when the issue came before a local superior court judge, he not only ruled that the statute was unconstitutional in its application to meth clan-lab synthesis (the legislature never intended that the statute be applied to meth clan-labs or their products), but he also ruled that the statute was unconstitutional on it's face – it was so overly broad as to be unenforceable (sola dosis applies). The prosecutor has appealed the judge's ruling, and the State's Attorney General is pushing hard to increase the penalties for meth clan-lab operation.

And so it goes - the saga continues.




Atomoxetine is the first non-stimulant treatment of Attention-Deficit/Hyperactivity Disorder (ADHD). It is prescribed in Capsules: 5 mg, 10 mg, 18 mg, 25 mg, 40 mg, and 60 mg.

Annual Business Meeting Minutes of the Society of Forensic Toxicologists, Inc.

October 22, 2003

The Annual Business meeting of the Society of Forensic Toxicologists, Inc., (SOFT) was held on October 22, 2003 at the Doubletree Hotel, Lloyd Center, Portland, OR. President Amanda Jenkins requested that the Secretary establish a quorum. A quorum of greater than 49 full members was present. President Jenkins called the meeting to order at 3.40 pm. Upon a motion duly made, seconded and passed, the agenda was approved. By a motion duly made, seconded and passed, the minutes of the annual business meeting of the Society of Forensic Toxicologists, Inc., of October 16, 2002, as published in ToxTalk, were approved by acclamation.

President's Report: Amanda Jenkins, Ph.D.

President Jenkins reported that the affairs of the society were in good order. Meetings were planned through to the year 2009. The administration of the society was improved, with the drafting of new Policies and Procedures, and of the formation of an Ethics Committee. She thanked the officers and the various committee members for their excellent work over the past year. President Jenkins made special mention of a proposal for the SOFT version of a "student academy". President Jenkins also challenged the membership to think about the importance of their work, and in particular give consideration to interpretative issues; she asked them to consider presenting papers on this topic at the upcoming meeting. Finally, President Jenkins thanked the members for coming to the meeting.

Secretary's Report: Graham Jones, Ph.D.

Secretary Jones thanked the Society for the opportunity and privilege of serving as Secretary over the past two years.

Treasurer's Report: Timothy Rohrig, Ph.D.

Treasurer Rohrig reported that SOFT is in good financial condition with assets totaling close to \$300,000 inclusive of the reserve account and the ERA fund.

Vice President's and Committee Reports: Daniel Isenschmid, Ph.D.

Vice President Isenschmid called on the committee chairs to give their reports:

A. Bylaws, Yale Caplan, Ph.D.

Dr. Caplan reported no activity during 2003, but anticipated actions during 2004.

B. Budget, Finance, & Audit, Ruth Winecker, Ph.D.

Dr. Winecker reported their review of the Treasurer's records for 2002 and through August 29, 2003. The records were found to be clear, concise and in good order. The financial records of the 2002 annual meeting have also been

reviewed and were found to be properly balanced and in good order.

C. Membership, Graham Jones, Ph.D.

Dr. Jones informed the membership that the current committee members were Dr. Michael Baylor, Dr. Adam Negrusz, Dr. Diana Wilkins, and himself as Chair. Membership of SOFT totaled 649, inclusive of 484 full Members, 100 Associate Members, 20 Charter, 14 Retired Charter, 18 Retired, and 13 Student members. Application and promotion forms are available on the SOFT web site.

D. ToxTalk, Joseph Monforte, Ph.D.

Dr. Monforte thanked the editorial board for their assistance over the past year. A special appeal was made for case notes and other papers; only three had been received over the past year. On a personal note, Dr. Monforte thanked those who wrote or sent e-mails expressing their concern and good wishes to him and Pat for their illnesses over the past year. Vice President Isenschmid thanked Dr. Monforte for his considerable efforts and dedication as *ToxTalk* editor over the past fifteen years.

E. JAT Special Issue, Karla Moore, Ph.D.

Special issue editor Karla Moore thanked the 54 reviewers, Barry Levine and JAT managing editor Julie Weber Roake for their hard work in getting the issue ready. She reported that 38 abstracts were originally received, resulting in 29 full manuscripts. Of those, two were rejected, two missed the deadline and two did not submit corrections, resulting in 23 papers in the special issue. Publisher Tinsley Preston presented plaques to Karla Moore and Barry Levine in recognition of their work.

F. Education Research Award and Young Scientist Meeting Award, Philip Kemp Ph.D.

Dr Kemp reported that the committee received 5 ERA applications this year. As instructed by the Board, two ERA awards were selected (each \$1000): Dustin C. Yaworsky (University of Connecticut) and Jimmy Crocket Jr. (University of Wisconsin). The committee selected Justin L Poklis, B.S to receive a Young Scientist Meeting Award (\$1000 plus a complementary meeting registration).

G. Meeting Resource Committee, Daniel Isenschmid, Ph.D.

2003 - Portland, Oregon, meeting hosts Kent Johnson and Vickie Watts reported that the meeting was very successful with 585 full registrations and 840 workshop registrations. The meeting received \$106,000 in sponsorship, thanks ir large part to the hard work of exhibitor liaison Lisa O'Dell. Acknowledgement was given to webmaster Bruce

Goldberger for his help with web-based registration and to the many local volunteers who assisted with the meeting. Awards were given to Scientific Program chairs Barry Logan and Ann Marie Gordon and, also, to the key people who helped with the on-site registration and local arrangements. David Watts, Kitty Jacobs and Bonnie Fulmer. Finally, gift certificates and plaques were given to Kent Johnson and Vickie Watts by President Jenkins.

2004 - Washington DC Co-host Marc LeBeau announced that the joint SOFT/TIAFT/FBI meeting would take place August 29 - September 3, at the flagship Marriott Marquis Hotel on Pennsylvania Avenue, close to the White House and major monuments. The FBI symposium at the beginning of the meeting would be free of charge and a rebate of specified expenses would be given to up to 900 attendees. The value of the rebate would be approximately \$628 each, covering 3 nights accommodation and four days of meal. The deadline for abstracts and registration for the FBI symposium would be May 3, 2004. A video presentation on the DC area followed.

H. Laboratory Guidelines, Graham Jones, Ph.D.

Dr. Jones reported no activity since the 2002 Guidelines were adopted by SOFT and AAFS. A critical review of the Guidelines is planned for 2004.

I. Drugs and Driving Committee, Fiona Couper, Ph.D.

Dr. Couper reported A short course on "The Effects of Drugs on Human Performance and Behavior' was held at the Borkenstein Center in Action, Indiana, March 16 - 19, coordinated by Dr. Barry Logan. This course will now be held annually. NHTSA is in the process of publishing several Drugs and Human Performance Fact Sheets. Two workshops and special sessions were held at AAFS and SOFT during 2003 (AAFS- Driving Under the Influence of Medically-Prescribed Drugs: SOFT - Drug Impaired Driving). A workshop has been proposed for AAFS in 2005 that will focus on factors that affect a driver's performance. such as fatique, diabetes, cell phone use, mental illness etc. Members from the AAFS/SOFT Drugs & Driving committee and the National Safety Council Committee on Alcohol and Other Drugs will hold a meeting on Saturday, October 18th Dr. Couper asked that SOFT members who have a DRE program in their area please pass along information about analytical methodology and cut-offs to Laurel Farrell.

J. Policies and Procedures, William Anderson, Ph.D.

Dr. Anderson reported that the Policies and Procedures electronic database has been split, one for data tables and the other for forms, search routines, program code etc., it now allows a search by date or date range. A draft copy of

a new Policies and Procedures document was prepared and given to Board members for review and comment.

K. Web-site, Bruce Goldberger, Ph.D.

Dr. Goldberger reported that the SOFT web site continues to be very popular; for example, in September alone the site had received 58,000 "hits"; 924 copies of the Guidelines were downloaded, as were 576 copies of the Portland meeting scientific program. He reported that SOFT has been using PayPal to facilitate web-based credit card transactions, but that SOFT will buy its own certificate to enable secure web-based payments. The web site was also moved to a new server in the fall, with new security and e-mail services. The Board has approved on-line dues payments starting in 2004.

L. Continuing Education Committee, Rebecca Jufer, Ph.D.

Dr Jufer reported that a Forensic Toxicology Review Seminar with 27 attendees was held at the University of Texas Health Sciences Center April 23-24, 2003, hosted by Vince Papa. A similar seminar with 62 attendees was held in Raleigh-Durham, NC, August 18-19, hosted by Jeri Ropero-Miller. An antidepressant workshop was held at the Portland SOFT meeting and may be offered as a local seminar at different locations.

M. Drug Facilitated Sexual Assault Committee, Marc LeBeau, MS.

Marc LeBeau reported that the committee continues to track educational seminars conducted by the core committee members. The Guidance Subcommittee is finalizing pharmacokinetic research on DFSA to prepare a manuscript for publication. The Research Subcommittee is finalizing a survey for distribution to forensic toxicology laboratories.

N. Ethics Committee, Aaron Jacobs, Ph.D. for Carl Selavka. Ph.D.

The mission of the committee is to develop, implement and maintain an ethics program that provides the SOFT membership with guidance, fairly assesses complaints and ensures documented, timely resolution of reported issues. Between October 2002 and February 2003, the committee completely revised the Ethics Committee Policies and Procedures document in order to comply with the SOFT Bylaws. In March 2003 revisions were made in response to comments received from the Board. The Ethics Committee Policies and Procedures are close to being finalized.

O. Nominating Committee, Laurel Farrell, B.A.

The nominating committee consisted of Laurel Farrell (chair), Ed Cone and Jeri Ropero Miller. Nominees for 2004 were.

Dr. Rohrig provided an outline of the AAFS Toxicology Section program planned for February 2004 in Dallas.

TIAFT - Marilyn Huestis, Ph.D. and Jim Gerostamoulos. Ph.D.

Dr. Huestis (TIAFT President) and Dr. Gerostamoulos (41st TIAFT meeting co-host) gave details of the upcoming meeting in Melbourne, Australia, November 16 – 20, 2003; host Dr. Olaf Drummer.

CAT - Sarah Kerrigan, Ph.D.

Dr. Kerrigan announced that the next CAT meeting would be November 7-8, in Los Angeles.

MATT - Laureen Marinetti, M.S.

The next MATT meeting will be in Arlington Heights, IL, with hair testing as a special topic.

ABFT -Yale Caplan, Ph.D.

Dr. Caplan announced the names of the newly qualified Diplomates. The Board is also working on an annual continuing education requirement for Diplomates and Specialists, probably to be implemented during 2004. The accreditation program continues to grow, with a total of 14 laboratories currently accredited. The Board is also considering a pilot proficiency test program of its own, perhaps late 2004 or during 2005. ABFT also hosted a successful workshop at the Portland meeting, attended by over 60 people, on preparing for laboratory accreditation by ABFT.

FTCB - Amanda Jenkins, Ph.D.

Dr. Jenkins reminded the meeting of the goals and programs of the FTCB and indicated that one of the main goals of the board at the moment was to work towards accreditation by the Forensic Specialties Accreditation Board (FSAB).

ICADTS - Barry Logan, Ph.D.

Dr. Logan announced that the International Committee on Alcohol, Drugs and Traffic Safety will hold its next meeting August 2004, in Glasgow, Scotland, hosted by Dr. John Oliver and Dr. Paul Williams.

President Jenkins asked if there was any unfinished business. There was no unfinished business.

President Jenkins thanked the outgoing officers and directors of SOFT and presented each of the following

Other Business

President Jenkins asked if there was any other business. Michael Schaffer asked the Board to consider offering more financial assistance to encourage more graduate and other students in toxicology programs to attend SOFT meetings. A motion was made by Michael Schaffer, and duly seconded, that starting with the Portland meeting, \$10 from each workshop registration be given to the ERA committee to help fund student stipends and assist graduate students in any way the committee feels appropriate. The motion was debated. a vote called, and the motion was defeated. After further discussion, a motion was made by Vickie Watts, and duly seconded, that profits from the 2003 Portland meeting be included in the SOFT treasury as a line item, until the ERA Committee can decide how those profits can be best utilized for the further education of our students. The motion was discussed, a vote called, and the motion was passed by majority vote.

No nominations for SOFT officers or directors were received from the floor. Motions were made and seconded to accept the nominations for each position, as submitted by the Nominating Committee. All officers and directors were elected by acclamation. The newly elected 2004 SOF1 officers and directors are as follows:
