Regional Toxicology Liaison – Quarterly Reflection and Progress Report

Quarter reported: October - December, 2023

Testimony training continued in the final quarter of 2023. The table below summarizes the year, including training in the last quarter and upcoming for 2024. Overall, the training was well received and incorporated the Drug Recognition Expert (DRE) State Coordinator or designee, a Traffic Safety Resource Prosecutor (TSRP) or designee, and an individual from the judiciary such as a Judicial Outreach Liaison (JOL). Due to scheduling conflicts, a few more trainings will be held in 2024 with continued funding support from Responsibility.org.

During Q4, the RTLs continued to meet with various state's SHSOs and highway safety partners for recurring meetings. In addition, the RTLs for R7 and R5 attended and presented at the annual SOFT conference. The focus of the presentation was to report out the work of the SOFT Toxicology Resource Committee (TRC), providing feedback from laboratories across the country. Over 150 laboratories were queried, and we received 96 responses from separate laboratories. Thirty-seven percent of laboratories test blood specimens while 37% test either urine only or a combination of blood and urine. Forty-seven percent of laboratories continue to utilize a stop testing workflow, meaning when the blood alcohol concentration (BAC) and/or illicit substance is detected at a certain concentration, comprehensive drug testing is not performed. The reasons for stop testing varied among the laboratories, some are in place due to workload, and others are directed by policy or statute. The RTLs will continue to work with the

laboratories in their regions to understand why stop testing occurs and find ways to provide support and resources. There have been requests to publish the outcomes from this work, and the RTLs will work with the TRC to write a publication that will be submitted to a peer-reviewed journal.

Project challenges:

The requests for assistance from non-represented regions continue to occur. The RTLs and the Project Manager (PM) work to provide guidance to the extent they are able. In most instances, the PM will provide consultation and resources. There have been several requests for testimony training in states that are outside of the current represented regions. The PM is keeping track of these requests, however, the states with regions 5, 7 and 9 will be given priority. One laboratory offered to cover all costs associated with the training and this will be considered as the remaining trainings are scheduled. Responsibility.org has agreed to continue to fund the trainings in the represented regions. Without the financial support from Responsibility.org, the testimony trainings would not be possible.

Not all laboratories have implemented the ASB documents. This will be addressed in the quarterly regional webinars as the RTLs will work to identify which ASB documents laboratories are struggling to implement and look for support and resources to assist. Standardization of laboratory testing is important as the RTLs begin exploring data harmonization in the coming years.

As always, the Buy America Act continues to hamper efforts to procure much-needed testing instrumentation using highway safety funding. The DUID Toolkit and related funding provided by NHTSA was very useful, but further funding and unique ways to circumvent the BAA are required.

Future goals:

Standardization is the primary goal for the RTLs in 2024. To compare data within and between states, the laboratories must achieve the same testing standards. The RTLs will gather feedback from each region's laboratories on whether or not they have implemented any ASB documents. Webinars targeting each of the standards and the process for implementation will be provided throughout 2024 in collaboration with the SOFT Continuing Education Committee.

In March the RTLs are leading a three-day webinar series focusing on method development and standardization. Each day will be about 4 hours of content and will feature presenters from different laboratories who will speak on their experience with different instrumentation. The last 2 days will include vendor-specific breakout rooms so attendees can ask questions relevant to the instruments in their laboratories.

Testimony training will continue on an ongoing basis. Some laboratories have asked for additional training and others have not been able to schedule the training due to various time constraints. The RTLs will ensure that the remaining laboratories in their regions receive the training.

Data harmonization continues to be a need. However, standardization must occur first. Throughout 2024, the RTLs will look to highway safety partners to understand the gaps in data and assist where necessary to build resources.
