This report summarizes the activities and accomplishments of the Regional Toxicology Liaison (RTL) program from October 2024 through September 2025. The RTL program is designed to strengthen state toxicology programs by enhancing support, communication, and resources. RTLs work collaboratively with forensic laboratories, traffic safety partners, judicial systems, and national organizations to improve toxicology testing, data reporting, and training across multiple regions in the United States.

An area the RTLs receive frequent requests is testing method development and validation. Implementing a new testing method, or increasing the scope of testing in a current one, is labor and time intensive and most laboratories do not have the resources to complete the work in a timely manner. Many take up to a year just to get a new method into production. The RTL program worked with Responsibility.org to fund a group to develop and validate two methods for a laboratory in California. The lab requested a THC method for blood and urine and a drug screening panel for a newly purchased LC-MS/MS. The work was completed earlier in the year and the THC method was successfully implemented. The screening panel was problematic for several reasons. The laboratory continues to work on implementation of the testing panel. The greatest takeaway was to better prepare and train the laboratory personnel before beginning the development and validation work and to ensure the laboratory has the internal resources to implement the method.

The RTLs focused much of their efforts on understanding the gaps in data, specifically as it relates to forensic toxicology and the DUI data systems in states. After attending the Association of Traffic Safety Information Professionals (ATSIP) Traffic Records Forum (TRF), the RTLs were included in the ATSIP Toxicology Working Group's activities. From there, a smaller subgroup was created that meets every two weeks. This subgroup is identifying a laboratory to use as a pilot for integrating forensic toxicology data into a state's DUI data system.

Mid-South Region Activities

Throughout the reporting period, the Mid-South RTL, Chris Heartsill, maintained a robust schedule of recurring engagements, including weekly RTL meetings, monthly Region 7 state conference calls, and participation in various national and regional committees. These included leadership roles in the National Safety Council's Alcohol Drug and Impairment Division (NSC-ADID), the Society of Forensic Toxicologists (SOFT), and the Organizational Scientific Area Committees (OSAC) Toxicology Subcommittee. Mr. Heartsill also contributed to the Midwest Toxicology Collaborative and impaired driving subcommittees in Missouri, Texas, and Oklahoma.

During this period, Mr. Heartsill provided testimony training and technical support to laboratories in newly added states, including Texas, Oklahoma, and Colorado. The expansion of the RTL program necessitated outreach to approximately 20 new laboratories, with efforts focused on understanding their operational needs and integrating them into the broader network of toxicology support. Mr. Heartsill facilitated meetings with laboratories in Houston, Tarrant County, and Dallas, as well as with the Colorado Bureau of Investigation, to discuss training and resource needs.

Mr. Heartsill actively participated in national conferences, presenting on topics such as ASB 122 alcohol calculations, toxicology interpretation in court, and the expansion of the RTL program. Notable presentations were delivered at the American Academy of Forensic Sciences, Lifesavers Conference on Roadway Safety, Southwest Association of Toxicologists Annual Meeting, Missouri Treatment Court Conference, International Association of Chemical Testing Annual Conference, Missouri Prosecutor Conference, and Kansas Judicial Conference.

In addition to conference presentations, Mr. Heartsill engaged in collaborative efforts with the National District Attorneys Association (NDAA) to revise the Alcohol Toxicology for Prosecutors monograph and supported AllRise in updating their Best Practices Manual for toxicology testing in treatment courts. He also contributed to webinars and planning sessions with the American Bar Association and provided scientific testimony for legislative hearings in Michigan.

Mr. Heartsill's involvement in standards development through OSAC and the [Academy Standards Board \(ASB\)](#) was instrumental in advancing consistency in toxicology testing and testimony. Participation in the development and adjudication of standards such as ASB 054 and ASB BPR 122 ensured that laboratories in the region had access to the latest guidelines and best practices.

Support for traffic safety initiatives included active participation in impaired driving task forces, collaboration with state highway safety offices, and presentations at judicial conferences. His efforts helped bridge gaps between laboratories and traffic safety partners, fostering a more integrated approach to addressing drug-impaired driving.

Overall, Mr. Heartsill's activities in the Mid-South region during this period reflect a comprehensive approach to enhancing forensic toxicology services, promoting standardization, and supporting the broader criminal justice and traffic safety communities.

Midwest Region

In the Midwest region, the RTL program has focused on strengthening relationships with forensic laboratories across Illinois, Indiana, Michigan, Minnesota, Ohio, Wisconsin, North Dakota, and South Dakota. Amy Miles, the RTL for this region, transitioned into her role by meeting with laboratories previously supported by Dr. Sabra Jones. She prioritized outreach to newly added laboratories in North Dakota and South Dakota, ensuring they received the necessary support and guidance. Throughout the reporting period, Ms. Miles facilitated connections between labs and highway safety partners, particularly in Ohio, where efforts are underway to convene a toxicology summit. She also provided scientific support for legislative initiatives in Illinois, Michigan and Indiana, including bills related to oral fluid testing and THC regulation. Ms. Miles actively participated in national and regional conferences, presenting on drug trends and toxicology standards, and co-led testimony training workshops at the International Association of Chemical Testing Annual Conference. Her involvement in organizations such as SOFT, ATSIP, and NSC-ADID has enabled her to advocate for data integration, laboratory standardization, and continuing education. She also contributed to the revision of the Alcohol Toxicology for Prosecutors Monograph and supported webinars and training for judicial and law enforcement partners. Her work has been instrumental in promoting consistency, collaboration, and innovation across the Midwest's toxicology landscape.

In addition to her work as an RTL, Ms. Miles is the RTL Program Manager. As such, Ms. Miles coordinates with states that are not currently represented by the program and offers assistance as time and resources allow.

Northeast Region

In the Northeast region, Dr. Sabra Jones has led efforts to engage laboratories and traffic safety partners across Connecticut, Maine, Massachusetts, New Hampshire, Rhode Island, Vermont, New Jersey, New York, Delaware, District of Columbia, Kentucky, Maryland, North Carolina, Pennsylvania, Virginia, and West Virginia. She conducted introductory meetings with over twenty laboratories to assess their needs and challenges, facilitating connections with instrument vendors and public health partners. Dr. Jones played a pivotal role in organizing and presenting at the Current Trends in Forensic Toxicology conference, which attracted over 1800 attendees globally. She also chaired the SOFT Toxicology Resource Committee and contributed to the development of standards through the Academy Standards Board. Her collaboration with state highway safety offices led to enhanced communication and planning, including follow-up meetings in North Carolina and presentations at regional conferences in Maine and West Virginia. Dr. Jones provided expert testimony and training for judicial audiences, including webinars on the *Smith v. Arizona* decision and presentations for drug court conferences. Her leadership in NSC-ADID and involvement in cannabis-related working groups have furthered the RTL program's mission to promote consistency and awareness in forensic toxicology. Her efforts have significantly advanced laboratory support, stakeholder engagement, and standards implementation throughout the Northeast.

Western Region

In the Western region, Kristen Burke has focused on supporting laboratories and traffic safety partners in New Mexico, Arizona, California, and Hawaii. Her work began with planning and advisement for Hawaii, which currently lacks a forensic toxicology laboratory. She collaborated with highway safety officials and potential testing providers to address this gap. In Arizona and California, Ms. Burke

facilitated technical assistance for laboratories, including support for testing methods involving emerging substances like mitragynine. She coordinated training and presentations for drug court conferences in Arizona and Mississippi, providing education on toxicology and drug trends. Her engagement with the California Impaired Driving Task Force and collaboration with DRE programs have strengthened the connection between toxicologists and law enforcement. Ms. Burke also contributed to legislative efforts in Michigan, offering scientific testimony on oral fluid testing and meeting with lawmakers to explain toxicology's role in impaired driving investigations. Her involvement in SOFT and NSC-ADID has enabled her to advocate for laboratory standards and share resources across the region. Through webinars, committee meetings, and direct consultation, Ms. Burke has advanced the RTL program's goals of education, standardization, and collaboration in the Western United States.
